**TERMS & CONDITIONS:**

The substance free community is an exciting living opportunity for students who do not smoke, consume alcohol, or use illegal drugs. Students can be confident that this community will be free of alcohol and other drugs regardless of individual choices made by fellow students. A substance free living environment is one where residents have agreed to keep their environment free of all types of smoke and/or tobacco products, alcohol, and illegal drugs at all times. This is a supportive community for students who, for clinical, medical, or personal reasons choose not to smoke, use tobacco products, consume alcoholic beverages, or use other illegal drugs. Students who are smokers or consume alcohol should not live in a substance free residence hall. All existing federal, state, and university regulations concerning alcohol, smoking, and other drug use are applicable in addition to the following standards:

**POLICIES:**

- A. The possession, use, or consumption of smoke/tobacco products, beverages containing alcohol, or illegal drugs will not be permitted in L.I.F.E. House at any time.
- B. Entering L.I.F.E. House in an inebriated or intoxicated state, or after the use of any smoke/tobacco products is prohibited, and in violation of this agreement. Entering L.I.F.E. House smelling of smoke, or otherwise creating a substance-related disturbance that negatively impacts individuals in the community, is a violation of this agreement.
- C. Residents of L.I.F.E. House are responsible for the behavior of their guests, and assume accountability for actions of their guests.
- D. Smokers and individuals who consume alcohol are not permitted to reside in L.I.F.E. House.

**CONSEQUENCES:**

- A. Any resident who violates the substance-free policy once will be required to relocate to another hall. Additional disciplinary action/sanctions will also be imposed.
- B. Residents of L.I.F.E. House that are found to be in violation of the alcohol, smoking, or illegal substances policies, as defined by the University, within any residence hall other than L.I.F.E. House, will be required to relocate to another residence hall. Additional disciplinary action/sanctions will also be imposed.

I agree to uphold the mission statement and comply with all policies of the L.I.F.E. House Agreement. By signing the L.I.F.E. House agreement, I am indicating that I have willingly requested and chosen to reside in L.I.F.E. House and fully understand my responsibilities as a member of the L.I.F.E. House community. I further understand that any violation of the L.I.F.E. House Agreement will render me ineligible to continuing residing in L.I.F.E. House and may result in additional disciplinary action.
