**Registration for the Fall 2025 term**

Students who received a Letter of Acceptance for the **Fall 2025** term must complete the following steps to complete the registration process.

New students are required to be in Vancouver and ready to attend Orientation. Please see Orientation and Class start for your program below.

**Orientation Dates:**

**September 2 to September 3**

**Fall 2025 Classes Start:**

**Thursday, September 4**

**Registration Deadline:**

The last day to register for classes is **Monday, September 15, 2025**. If you cannot start attending classes by this date, you will be removed from classes.

**Registration Process:**

Please note that there are different stages of registration.

To initiate REGISTRATION, you need to:

**1. Provide proof of your immigration status.**

Please upload a legible copy of your proof of immigration document. If you are a Domestic student, please upload a copy of your Canadian Passport or Canadian PR card to proceed with your registration. If you are an International student, see the list of accepted documents [here](#).

**IMPORTANT:** Only Study Permit *with Fairleigh Dickinson University*, Port of Entry Letter, Study Visa, or online approval letter (inside Canada applications) are accepted to proceed with registration. If you are still waiting for your immigration documents, please wait until you have them to start the registration process.

If you don't have access to your online application portal, please **contact your agent** to complete this first step. Please upload a legible copy of your proof of immigration document. If you are a **Domestic** student, please upload a copy of your Canadian Passport or Canadian PR card to proceed with your registration. If you are an **International** student, see the list of accepted documents [here](#).

Once we verify the documents, we will send you an email with instructions

regarding the next steps. If you have uploaded the proof of immigration for a previous application but deferred to the Fall 2025 term, you will need to upload the document again in the **Proof of Immigration Status - Fall 2025 Vancouver**.

## 2. Take the FDU English Placement Test (EPT)

To check if you need to test before registering for courses, please check the "Conditions" section in your on-line application portal under the "Required Documents" tab. **Ask your agent** for assistance if you do not have access to the applicant's portal. If you need to test, we will contact you with further instructions on how to book and write the [FDU English Placement test](#) within 5 business days of the day when you provided your immigration documents.

If you were already placed into your academic program based on your English proficiency scores at admission, or you already have EPT scores, you will be registered into your classes. If you took the FDU EPT test more than 2 years ago, your score may have expired, and you may be required to retake the test before you are allowed to register for classes.

***Starting from June 30<sup>th</sup>, Enrollment Services will complete the Fall 2025 registration for students who have completed the above 2 steps. You will receive an email with instructions on how to check your course schedule and tuition statement. You must confirm your registration and pay any***
