

Winter 2026 Registration

REGISTRATION STEPS

- **1. SUBMIT** your course plan now if you <u>have not</u> received an approval from your program coordinator. If your courses were already approved Approved, you don't need to resubmit your plan for approval.
- 2. ADD your preferred section to Vancouver Winter 2026 term in Self-Service as below.



3. REGISTER for the approved sections on your designated registration day.

Priority Registration Dates for MHMS Students

Online priority registration for Winter 2026 will open on **November 12, 2025** at **8:00 am Vancouver time**. Registration priority will be based on the *number of credits completed*.

- Students who have completed 9 credits or more can register on Wednesday, November
 beginning at 8:00 am VANCOUVER TIME.
- Students who have completed **3 credits or more** can register on **Friday, November 14** beginning at **8:00 am VANCOUVER TIME**
- Students who have completed less than 3 credits can register on Sunday, November 16 beginning at 8:00 am VANCOUVER TIME.

NOTES

**For detailed course information and description please refer to Course Catalog in Self-Service.

^{*}Self-Service shows registration times in Eastern Time, which is 3 hours ahead of Vancouver time or Pacific Time. For example, 11 am November 12 will be 8 am November 12 Vancouver time.

- ** <u>Course offerings, schedules, and instructor details are subject to changes</u>. Check your Self-Service account regularly up until the start of Winter 2026 for any updates.
- **Students who are unable to register or add/drop courses due to account holds must contact the Enrollment Services Office at esvancouver@fdu.edu.
- **Students with outstanding balances will NOT be allowed to register for classes.

WAITLISTS

If a course is full, you can place yourself on the waitlist by clicking the "Waitlist" button in Self-Service. You will receive an email if you get permission to register from the waitlist. Check your email regularly as you must *register within 24 hours* after receiving the email.

IMPORTANT DEADLINES

- **January 7, 2026:** Last day for online registration/schedule changes *using Self-Service*. No penalty.
- **January 8, 2026:** Winter 2026 term starts. **Penalties apply** when dropping or switching courses from that day. Registration and adding/dropping courses must be done using the <u>Registration Form</u> and <u>Change of Schedule Form</u>. Full winter tuition fees are due.
- **January 19, 2026:** Last day for registration, adding/dropping courses. After that, students can only withdraw and receive 'W' grade in transcript.

Before changing courses, always consult with your program coordinator to ensure they meet your program requirements.

TUITION FEES

Statement of fees will be available in Self-Service following your registration.

Winter tuition fees are due by January 8, 2026. As of January 9, late penalties will apply according to the policy on our website.
